

# CORAL COAST TOURIST PARK

## PET RULES

***PETS ARE ALLOWED WITH PRIOR APPROVAL OF MANAGEMENT AND SUBJECT TO THE FOLLOWING CONDITIONS:-***

1. DOGS MUST BE RESTRAINED ON A SHORT LEASH AT ALL TIMES WHILST IN THE PARK.
2. DOGS MUST BE WALKED OUTSIDE THE PARK
3. DOGS MUST NOT BE LEFT UNATTENDED IN THE PARK WITHOUT PRIOR APPROVAL/ARRANGEMENTS WITH MANAGEMENT
4. PETS ARE **NOT** ALLOWED IN OR AROUND THE POOL, SHOP, AMENITIES / LAUNDRY AREA, GARDENS, CAMP KITCHEN OR ANY OTHER AREA WHERE FOOD MAY BE PREPARED OR EATEN.
5. NO VISITORS PETS ARE ALLOWED IN THE PARK.
6. TENANTS ENTERING THE PARK WITHOUT A DOG ARE **NOT** PERMITTED TO ACQUIRE A DOG AFTER ENTERING WITHOUT THE PERMISSION OF MANAGEMENT.
7. WASHING AND OR DRYING OF PET TOWELS,BLANKETS ETC IN THE PARK WASHING AND DRYING MACHINES IS **NOT** ALLOWED.
8. DOG WASTE MUST BE DISPOSED OF BY PLACING WASTE IN A PLASTIC BAG,TIED AND PLACED IN A GARBAGE BIN. PLEASE REMEMBER THAT THERE ARE OTHERS WHO FREQUENT AND OR WORK IN THE PARK - THEY DO **NOT** NEED TO BE REMINDED OF SOMEONE ELSE'S DOG BUSINESS.
9. DOG OWNERS ARE REQUIRED TO KEEP THEIR DOGS OFF ALL GARDENS AND MUST NOT ALLOW THEIR DOGS TO RELIEVE THEMSELVES ON THE GARDENS.
10. DOG OWNERS AGREE TO TAKE FULL RESPONSIBILITY FOR ANY PERSONAL INJURY OR DAMAGE CAUSED BY THEIR DOG WHILST WITHIN THE CONFINES OF THE PARK AND AGREE TO PAY FOR ANY CLAIMS OF COMPENSATION IN RELATION TO THE DOGS ACTIVITIES.
11. APPROVED PETS ARE ALLOWED TO BE KEPT WITHIN THE CONFINES OF THE DESIGNATED AREA OF THE PET FREINDLY CABIN. PETS MUST BE ON A CURRENT FLEA / TICK PROTECTION & BE HEALTHY
12. PETS ARE NOT ALLOWED IN ANY ACCOMMODATION THAT IS NOT DESIGNATED AS A PET FRIENDLY CABIN.
